## VENDOR HOLD HARMLESS AGREEMENT

VENDORS AGREE TO ABIDE BY ALL REQUIREMENTS AND REGULATIONS SET FORTH BY HURA TAHITI OF SOUTHERN CALIFORNIA, HITIA O TE RA, HOPE INTERNATIONAL UNIVERSITY AND THE CITY OF FULLERTON. FAILURE TO ADHERE TO THE REQUIREMENTS AND REGULATIONS MAY RESULT IN THE CLOSURE OF YOUR BOOTH AND FORFEITURE OF FEES PAID TO HITIA O TE RA AND FUTURE PARTICIPATION AT THE HURA TAHITI TAHITIAN DANCE COMPETITION.

- VENDORS ARE RESPONSIBLE AND LIABLE FOR ALL TAXES AND FINANCIAL RECORDS AND REPORTING AS A RESULT OF YOUR PARTICIPATION AT THE HURA TAHITI DANCE COMPETITION 2011. IN ADDITION, CALIFORNIA STATE LAW REQUIRES IN THE EVENT OF AN ON-SITE AUDIT, YOU MUST HAVE YOUR CALIFORNIA SELLER PERMIT WITH YOU. **NO EXCEPTION.**
- VENDOR MAY ONLY SELL ITEMS THAT HAVE BEEN LISTED ON YOUR APPLICATION AND PREVIOUSLY APPROVED BY THE HURA TAHITI BOARD.
- VENDORS MUST SUPPLY THEIR OWN TABLES, CHAIRS, CANOPIES; ALL BOOTHS SPACE SHOULD BE 10 X 10.
- VENDORS ARE RESPONSIBLE FOR THEIR OWN SECURITY AT NIGHT. HURA TAHITI, HITIA O TE RA AND THE HOPE INTERNATIONAL UNIVERSITY, ITS OFFICERS, AGENTS, VOLUNTEERS WILL NOT BE HELD LIABLE FOR ANY LOST OR DAMAGED ITEMS.
- VENDORS MUST HAVE THEIR TENTS SET UP BY 9 AM. EACH DAY.
- VENDORS AND THEIR WORKERS SHALL INDEMNIFY, DEFEND AND HOLD HARMLESS, HURA TAHITI, HITIA O TE RA, HOPE INTERNATIONAL UNIVERSITY AND THE CITY OF FULLERTON, THEIR OFFICERS, EMPLOYEES, AGENTS AND VOLUNTEERS FROM ANY AND ALL LOSS, DAMAGE OR INJURY TO ANY PERSON OR PROPERTY TAKING PART IN THE HURA TAHITI DANCE COMPETITION HELD AT THE HOPE INTERNATIONAL UNIVERSITY IN FULLERTON.
- VENDORS ARE RESPONSIBLE FOR MAINTAINING AND CLEANING THEIR RESPECTIVE AREA EACH DAY.
- VENDORS MUST CARRY A FIRE EXTINGUISHER IN THEIR BOOTHS.
- VENDORS MAY NOT SELL ANY WATER, SODA OR ANY FORM OF DRINKS, ONLY HURA TAHITI AND HITIA O TE RA GROUP CAN SELL DRINKS FOR THE 2 DAYS EVENT.
- HURA TAHITI ANTICIPATES THAT EACH VENDOR WILL CONDUCT THEMSELVES WITH THE HIGHEST STANDARD BEST REPRESENTING THE SPIRIT OF OHANA AND ALOHA. WE RESERVE THE RIGHT TO ASK YOU TO CURTAIL, REFRAIN AND CEASE ANY BEHAVIOR OR ACTIVITY NOT IN KEEPING WITH THE STANDARDS OF HURA TAHITI. NONCOMPLIANCE WILL RESULT IN THE CLOSURE OF YOUR BOOTH WITHOUT THE REFUNDING OF YOUR BOOTH FEE.
