HOLD HARMLESS AGREEMENT.

FOR SOLOISTS AND GROUPS.

EACH PARTICIPANT ORGANIZATION SHALL HOLD HARMLESS AND INDEMNIFY HURA TAHITI DANCE COMPETITION OF SOUTHERN CALIFORNIA AND HITIA O TE RA BOARD MEMBERS, MEMBERS, VOLUNTEERS AND THE CITY OF FULLERTON AND HOPE INTERNATIONAL UNIVERSITY FROM EVERY LIABILITY, CLAIM OR DEMAND, WHICH LIABILITY, CLAIM OR DEMAND MAY BE MADE BY REASON OF:

- A. ANY INJURY TO PERSON(S) OR PROPERTY, SUSTAINED BY ANY PERSON, FIRM OR CORPORATION CAUSED BY ANY ACT, NEGLIGENCE, DEFAULT OR OMISSION OF THE PARTICIPATING ORGANIZATION OR ANY PERSON, FIRM OR CORPORATION DIRECTLY OR INDIRECTLY ENGAGE BY IT UPON OR IN CONNECTION WITH THE EVENT, WHETHER THE INJURY OR DAMAGE OCCURS AT THE HURA TAHITI COMPETITION OF SOUTHERN CALIFORNIA VENUE-HOPE INTERNATIONAL UNIVERSITY, HITIA O TE RA, HOST HOTELS OR ANY OTHER RELATED LOCATION.
- B. THE FURNISHING OR USE OF ANY COPYRIGHTED COMPOSITION, SECRET PROCESS PATENTED OR UNPATENTED INVENTION, ARTICLE OR APPLIANCE DURING THE EVENT.

THE PARTICIPATING ORGANIZATION AT ITS OWN COST, EXPENSE AND RISK SHALL DEFEND ALL LEGAL PROCEEDING THAT MAY BE BROUGHT AGAINST THE COMMITTEE, ITS BOARD, OFFICERS AND VOLUNTEERS ON ANY SUCH LIABILITY, CLAIM OR DEMAND AND SATISFY AND RESULTING JUDGEMENT THAT MAY BE RENDERED AGAINST ANY OF THEM WHETHER OR NOT THE LIABILITY, CLAIM OR DEMAND WAS ACTUALLY OR ALLEGEDLY CAUSED WHOLLY OR IN PART THROUGH THE NEGLIGENCE OR OTHER IMPLYING CONDUCT OF ANY OF THEM.
